NOW, THEREFORE, for and in consideration of the mutual covenants and other good and valuable consideration, LARRY A. DUKE and IVA B. DUKE, and MARK FOWLER and LARA FOWLER hereby agree as follows:

1. Each party does hereby give and grant unto the other party a perpetual fence line easement over and across a strip of land eighteen inches (18") wide on either side of the adjoining property line for the

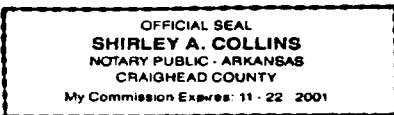
